SPECIAL NOTES, DISCLSUORES AND DISCLAIMERS:

1. The Client and Mega Music D.J. Services agree that this contract and any attached addendums are not subject to cancellation unless both parties have agreed to such cancellation in writing.
 - a. Fees due / Refunds will be based on the following:
 - b. More than 60 days notice, no additional fees due, Deposit is Forfeited, or applied to different date.
 - c. 45 to 60 days notice, fees due will be ½ of the contract fee, less any amount paid as the security deposit or a Minimum of \$500 which is less..
 - d. Less than 45 days notice, all fees will be due as agreed upon in this contract.
2. In the event the Client breaches the contract, he or she shall pay Mega Music D.J. Services the an amount set forth in this contract as liquidated damages, in addition 6% interest thereon for payment not made within 7 days, plus a reasonable Attorney, Court and Collection fees. The damages amount shall be the amount of this contract or \$500 which ever is more.
3. It is hereby further agreed; that the Client shall be held liable for any injury or damages to the Mega Music D.J. Service Staff, or property of Mega Music D.J. Service (owned or leased), while on the premises of said event, if the damage or injury is caused by the Client, a guest of the client, members of his/her organization, event invitees, employees, or any other party in attendance, whether invited or not. This clause is not intended to nor does it hold the client responsible for the action of the venues staff or the fault of the venue's facilities. Furthermore, this clause is not intended to nor does it hold the client responsible for injuries or damages caused solely by the Mega Music D.J. Services staff to him/herself or the equipment.
4. It is understood that if this is a "Rain or Shine" event, Mega Music D.J. Services compensation is in no way to be affected by inclement weather. For outdoor performances, Client shall provide overhead shelter for setup area. There should be no chance of water damage, falling objects onto equipment, excessive heat, cold, etc. The Mega Music D.J. Services Staff reserves the right, in good faith, to stop or cancel the performance should the weather pose a potential danger to our staff, the equipment, or audience. Every effort will be made to continue the performance. However, safety is paramount in all decisions. The Mega Music D.J. Services compensation will not be affected by such cancellation, unless mutual agreed upon.
5. The Client is responsible for providing a "reasonably" secure stage area with easy access. Size of the stage area will directly affect our ability to provide the optimal show. We recommend discussing this matter before signing the contract. In the event of an abundance of stairs more than two flights 12 steps each or less, the Client will be obligated to pay an additional minimum fee of \$50. The Fee shall be determined at the time the agreement is signed, If this information is not disclosed at the contract signing, the fee will be a minimum of \$100. The Mega Music D.J. Services staff will use their discretion in determining if the site is safe for setting up the equipment. There should be no chance of water damage, falling objects onto equipment, excessive heat, cold, etc.
6. If Mega Music D. J. Services is providing music before or during a dinner, the Client is responsible for providing dinner for the D.J.(s) that are performing at the event, the number will be determined in advance, a minimum of 2 should be used as a general rule. The D.J.(s) should be seated in a place close to the equipment to ensure are ability to monitor the equipment and make adjustments to it as needed.
7. The client is responsible for providing, (3) three standard chairs, Minimum of (2) two 120V 20 amp AC electrical outlets, each on it's own circuit, that must be located within (25) fifteen feet of where Mega Music D.J. Services staff must set up the equipment, for optimum performance (3) three outlets, preferably on different circuits, allow the best opportunity to provide the Client with the best show of sound and lights. The third outlet may be up to (50) feet away. The AC outlets must be able to accommodate a (20) twenty-amp load. Mega Music D.J. Services staff will be running cords to these outlets. We will not place our electrical cords in a manner that will cause them to be walked upon. Outlets that are located on the same wall where the equipment is to be set-up is optimal. (This is a safety and fire hazard issue that will not be compromised.)
8. In the event of circumstances that present a threat or implied threat of injury or harm to Mega Music D.J. Services staff or any equipment in Mega Music D.J. Services possession, Mega Music D.J. Services reserves the right to cease performance. If the Client is able to resolve the threatening situation in a reasonable amount of time (maximum 30 minutes), Mega Music D.J. Services shall resume performance in accordance with the original terms of this agreement. Client shall be responsible for payment in full, regardless of whether the situation is unresolved or whether Mega Music D.J. Services resumes performance. In order to prevent equipment damage or liability arising from accidental injury to any individual attending this performance, Mega Music D.J. Services reserves the right to deny any guest access to the sound system, music recordings, or other equipment.
9. Mega-Music must and will comply with all local Laws and Ordnances regarding Show times, Loud Music, Nuisances ordnances and other laws as applicable. The Client will be responsible for any damages regarding such items.
10. Mega Music D.J. Service's Liability shall be limited to the fee amount of this contract. Mega Music DJ Services will not be held responsible for things beyond our control (e.g. transportation complications while in route to the location such as an accident or divergent traffic conditions). In the event, the location given is INCORRECT; the client will not be compensated or refunded in anyway.
11. Bookings are made on a first come basis and are only confirmed by a signed agreement and paid deposit. Mega Music D.J. Service recommends you book early to guarantee your date.
12. Payment for "Unexpected" overtime requested and/or required the date of the event, is due at the event in cash or money order, unless prior arrangements are made.
13. Permission is hereby granted to Mega Music D.J. Services the irrevocable and unrestricted right to use and publish photographs of me the client and /or the organization and/or the event I represent, or in which I / we may be included, and as far my guests should be considered fair use. Mega Music D.J. Services may use photos taken for publications, electronic reproductions (web sites) and/or promotional materials or any other purpose and in any manner or medium. In addition, I grant my permission to alter the same without restriction; and to copyright the same. I hereby release the photographer and Mega Music D.J. Services from all claims and liability relating to said photographs.
14. In the event legal action becomes necessary, the losing party is liable for all legal fees pertaining to the manners at hand concerning this event.
15. In the event of any guest at this function experiences any discomfort, the liabilities of the Disc Jockey and Mega Music DJ Services is limited to, upon the client's request, immediately curtailing the issue of the cause of discomfort. Our show contains or may contain loud Music, flashing lights, Strobe lights, and/or simulated smoke, the client is responsible for notifying those attending the event of these issues to prevent health problems or notifying Mega Music D.J. Services in advance not to use any or all of these items.
